

ibüümerang Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.ibuumerang.com and ibüümerang and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to ibüümerang include www. ibüümerang.com . The ibüümerang website is an e-commerce site. By using the ibüümerang website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, ibüümerang may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Birthday

If you purchase ibüümerang's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

ibüümerang may also collect anonymous demographic information, which is not unique to you.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

ibüümerang collects and uses your personal information to operate its website(s) and deliver the services you have requested.

ibüümerang may also use your personally identifiable information to inform you of other products or services available from ibüümerang and its affiliates.

Sharing Information with Third Parties

ibüümerang does not sell, rent or lease its customer lists to third parties.

ibüümerang may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to ibüümerang, and they are required to maintain the confidentiality of your information.

ibüümerang may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on ibüümerang or the site; (b) protect and defend the rights or property of ibüümerang; and/or (c) act under exigent circumstances to protect the personal safety of users of ibüümerang, or the public.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by ibüümerang. Security of your Personal Information

SSL Protocol

security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.


